Cancellation/Refund Policy

If you need to cancel, you must call 10 business days before the start of the program in order to transfer to a future program. No refunds are given unless the child suffers a medical emergency or illness. No transfers or refunds are given for orders canceled within 10 business days of the program.

Camp Times

Morning camps begin at 9am and end at 12pm. You may drop off your child no earlier than 8:45am. Afternoon camps begin at 1pm and end at 4pm. You may drop your child off no earlier than 12:45pm. The museum is open to the public from 9:30am – 11:30am and 1:30pm – 3:30pm, with a closure between to allow for camper pick up and museum sanitizing. Campers attending both morning and afternoon camp will have a lunch break from 12pm – 1pm outside of the museum.

Location and Directions

Campers will be dropped off to camp staff outside the Shenandoah Valley Discovery Museum, before camp starts. Pick-up will occur in a similar fashion. Adults must come with your child for drop off and to pick up. We do not release unchaperoned students from programs due to issues of safety and liability.

Health Information

If your child has a medical condition, peanut or other severe allergy, dietary restrictions, or other special need, please inform registration staff as soon as possible so we can make accommodations. Call (540) 722-2020 x 106. Please complete the attached health forms when you register for camps.

What to Wear/Bring

- The museum is not responsible for lost, missing, or damaged personal items.
- Campers are asked to bring their own snack and bottled water. If attending camps or classes all day, bring a bag lunch and a drink. **We are a nut-free museum, so please, nut-free snacks only, and no PB&J sandwiches!** Also, no refrigeration is available, nor are we able to heat up lunches.
- Wear closed-toed shoes and comfortable clothing that can get messy.
- Additional materials may be required by your camp counselor.
- Please leave valuables like collectable cards and personal electronics at home. Electronics brought to the camp will be held in a safe place until the end of the program day

Behavior Policy

In order to make the experience of our programs a positive one for all students and staff, we have established a policy to manage behavior incidents that involve chronic disruption of classes and/or safety. How Camp Will Look Different For Summer 2021

The Discovery Museum has redesigned the 2021 summer camp program to align with local, state and CDC guidelines to provide campers and counselors with a fun and safe experience this summer at camp! Please read the following information to learn more about what we're doing to maintain a healthy environment and what you can do before you bring your child to a SVDM Summer Camp.

Safety Measures

Counselors and Counselors-In-Training (CITs), will wear masks at all times. All campers are required to bring and wear a mask.

Drop-Off and Pick-Up

Campers will be dropped off and picked up outside the building to limit contact. Camper drop-off will occur between 8:45am – 9:00am and 12:45pm – 1:00pm. Pick-up will occur from 11:45-12:05 and 3:45-4:05.

Camp Hours/Museum Hours

The museum will be open to the public during summer camps. These hours are 9:30am-11:30am and 1:30pm-3:30pm. Campers will remain in their camp space during open hours. Between 11:30 and 1:30, the museum staff will sanitize and reset the museum. Campers who are staying for an afternoon camp will have a lunch break from 12pm – 1pm. This will take place, using social distancing guidelines, across the street at George Washington's Office.

Camp Sizes

Campers will be placed in groups of no more than 10-12, with one SVDM counselor, and up to 2 additional CITs unless the CDC offers additional grouping guidelines or flexibility. Campers will remain in their groups and with their counselor throughout the day and social distancing will be the general rule. Camper access to the museum floor space will be scheduled to avoid intermingling of groups.

Activities

Our creative camp staff has planned activities that are engaging and that will also keep your child as safe as possible. All camp activities have been modified to respect social distancing guidelines. Activities may include arts and crafts, games, fitness activities, brain games, science experiments, STEM challenges and more.

Maintaining a Healthy Environment Each Day

Campers will be asked to wash hands upon arriving to camp, before and after snack, before and after going out into the museum, and at other times during the day. Camp activity protocols include frequent disinfection of high-touch, high-traffic areas, and daily overnight enhanced cleaning. Activity areas will also be cleaned in between morning and afternoon camps.

Any campers who show any sign of illness or fever during the camp day will need to be picked up immediately. Siblings will also be required to leave camp for the day. Campers and siblings may return to camp after being fever-free and symptom-free for three days without medicine.

The Discovery Museum appreciates your patience, flexibility, and graciousness as we continue to make adjustments so that our SVDM Camps run smoothly with health and safety as our top priority.
